

A MESSAGE FROM THE PRESIDENT

In this third year as president, I want to acknowledge the work of our board members who provide governance and vitality to PHG through their work as a full board, executive committee, theme committees (Heritage, Environment, Recreation, Arts and Culture), administrative committees, and volunteer support to our programs and events. The commitment, special expertise, and energy of each board member is an incredible strength of PHG. I also want to thank our valued staff member, Rachel Pierson, who is moving on from PHG to a career in youth education, and welcome Hannah Emmons, who will replace Rachel as our full-time community programs coordinator.

My personal memories of the past year include the following special moments in our quest to preserve, protect, interpret, and restore the environment, history, and culture of the Patapsco River Valley:

- Agroforestry- The practice of growing trees and shrubs that provide agricultural products, such as fruits, nuts and berries, has the potential to transform farms, parks, and residences into areas that produce economic benefit while promoting biodiversity. I joined PHG staff on a visit to Centreville, MD where Maryland DNR Forestry described their program and demonstrated a pilot project. Later, we involved the Young African Leaders Initiative (YALI) in one of our agroforestry plantings in Patapsco Valley State Park.
- Choose Clean Water Conference- At this regional gathering of scientists, managers, advocates, and students for clean water, PHG staff and I presented a session on vernal pools and led a field exercise in vernal pools and water quality monitoring.
- Nike Missile Site- After a year of nurturing, the Heritage Committee led by Tom Somers sponsored the first public event at the Nike Missile Site BA-79 in Granite, MD. I, along with 200 others, learned the history of and saw the restored facilities of this part of the first missile defense system in the U.S.
- Green Community Leadership Award- Lastly, I was proud to attend, with PHG Executive Director Aaron Shapiro and Secretary Ken Boone, the presentation of our Green Community Leadership Award by Howard County Executive Calvin Ball and Howard Community College President Dr. Daria Willis.

This annual report highlights these and many other accomplishments of the past year and sets the stage for our continued future success. Please take time to read the report and find events and programs to enjoy and support as a volunteer or donor.

MHAA GRANT FUNDS

The Maryland Heritage Areas Authority (MHAA) awarded matching grants totaling \$428,300 for Patapsco Valley Heritage Area (PVHA) non-profits. These FY25 funds support heritage tourism projects and activities that draw visitors and expand economic development and tourism-related job creation throughout Maryland.


In addition, Patapsco Heritage Greenway (PHG) received a management grant for \$100,000, a block grant for \$25,000, and a marketing grant for \$17,500. PHG's management grant supports organizational operations and staffing. The marketing grant will help promote and highlight heritage tourism opportunities for visitors to the PVHA. All funds from the block grant will be used to support mini-grants to PVHA partners and stakeholders.



PARTNERSHIPS

PHG provided \$43,437.50 to partners in the Patapsco Valley Heritage Area through our mini-grant, EC250 Legacy Fund, and sponsorship programs.

MINI-GRANT PROGRAM

Patapsco Heritage Greenway's (PHG) Mini-Grant Program is designed to assist heritage-related sites, organizations and municipalities to develop new and innovative programs, partnerships, exhibits, tours, events, and other initiatives consistent with the regional goals and objectives stated within our state and county approved management plan. The program encourages proposals that include collaborative partnerships, enhance preservation, encourage stewardship of natural resources, and promote heritage tourism.

This year, PHG received \$38,700 in grant requests for the Program, which is funded by a \$25,000 grant from the Maryland Heritage Areas Authority. This year's awardees were chosen through a competitive process and PHG was able to award \$26,500 in funding.

HERITAGE

During FY24, the Heritage Program's accomplishments fall into three different categories, including event planning and facilitation, program building, and professional development.

Regarding event planning and facilitation, we have planned and hosted various in-person events, including multiple Patapsco Days lectures, the Third Annual Wagandt Memorial Lecture, and the Nike Missile Site BA-79 Open House, which drew over 200 attendees. We have also helped to host various cemetery cleanups at the Oella Cemetery with the environmental program manager and community programs coordinator.

The Heritage Program has made strides in both developing new initiatives and maintaining or expanding existing ones. For example, the cemetery preservation program that was established at the end of FY21/early FY22 (though still a work in progress) has been able to work closely with community members to make notable progress with efforts at the Historic Oella Cemetery, Serenity Ridge Natural Burial Cemetery, and Whipps Garden Cemetery. We have also worked closely with the ad hoc Oella cemetery committee to create successful applications for funding from PHG and MHAA.

PHG's Heritage Program Coordinator, Kyla Cools, pursued several professional development opportunities, including presenting at the American Alliance of Museums annual meeting and attending workshops hosted by organizations such as the

PHG and other local organizations planned an Open House event at the Nike Missile Site BA-79, offering participants tours of the grounds and insights into its historic significance. PHG has continued to work at the Oella Cemetery along with community members to help preserve this historic landmark.

Maryland Historical Trust, Smithsonian National Museum of American History's Center for Restorative History, Preservation Maryland, and more. These experiences enabled PHG to share its Heritage Program projects with a broader audience, learn from other organizations in Maryland and the nation, and reflect on best practices for interpreting and educating about the history and culture of the Patapsco Valley. A goal for FY25 is to continue participating in professional development and potentially present at another conference.





ENVIRONMENT

As part of our mission to preserve and protect the natural resources of the Patapsco Valley Heritage Area, volunteer events are held throughout the year to help clean up trash, remove invasive species, and plant trees. We greatly appreciate the effort of our volunteers to make an impact in the health of the Patapsco River Valley and help us achieve our goals.

WATER QUALITY MONITORING

In June 2024, we released our second **Non-Tidal Patapsco River Report Card**, issuing a C+ grade for the non-tidal portion of the river based on five parameters measured from May 2022 to April 2023. The parameters included in the grade are biology, conductivity, clarity, E. coli bacteria counts and phosphorus. This is a slight improvement over the first years' report card grade. We adhere to Chesapeake Monitoring Cooperative's (CMC) protocols and quality assurance procedures, which allows our data to be compared across the Chesapeake Bay Watershed and stored in the CMC's Data Explorer database. The data are accessible for public and agency use.

During the first half of FY24, we continued our bimonthly water quality sampling at eleven sites in the watershed. At the beginning of 2024, we reduced our data collection schedule to monthly and began evaluating additional possible sites to include for FY25. Parameters monitored have remained the same since the inception of the program and include temperature, pH, conductivity, nitrite, phosphorus, dissolved oxygen, water clarity and E. coli bacteria counts. Additionally in the second half of FY24, we ran a rigorous side-by-side comparison of bacterial monitoring procedures with an intern from the University of Maryland School of Public Health. The results of that project have not only helped us forge our path ahead, but have also benefited the wider volunteer monitoring community across the region.

BIOLOGICAL MONITORING

Using stream invertebrates for biological assessment, we completed two more full seasons of biological monitoring in FY24 using Izaak Walton League/Save Our Streams protocols. We trained twelve new community scientists to be certified in the procedures as well as providing scores of other educational monitoring opportunities. We collected data at all eleven sites, finally including Deep Run as a stream monitoring location using a slightly different protocol than the rest of our rocky-bottom streams. We piloted a winter monitoring protocol at three sites and plan to expand this further in the future. An additional site will be added to the roster for FY25.

We provided over 150 hands-on, in-depth volunteer opportunities to learn about water quality, monitoring and potential threats to water quality. We engaged hundreds more in less formal opportunities to learn about water quality, land use and residential yard management through educational experiences at schools, streamside community events, and workshops.

 Throughout the year, PHG engaged community members in hands-on learning to assess macroinvertebrate populations and gain insights into water quality.



COMMUNITY & GROUP PROGRAMS

PHG continued to expand our community and group programs during FY24 including collaborating with new and existing partners, local community and neighborhood groups, corporate organizations, and schools on a variety of events. These included bilingual family and community days and cross-cultural programming at Patapsco Valley State Park, educational workshops in partnership with afterschool programs, scouting groups and summer camps, tree planting and maintenance initiatives involving elementary and middle school students as well as local businesses, and much more. Through our programs, PHG actively strives to cultivate a sense of place and belonging in the Patapsco Valley watershed while advocating for stewardship of our natural, cultural and historical resources.

We expanded our impact across the Patapsco watershed in both Baltimore and Howard Counties, including continuing our work in the communities of Milford Mill, Randallstown, Lansdowne, and Elkridge. Our efforts are aimed at fostering safer, healthier, and cleaner environments for all residents. This has been possible through impactful collaborations with our dedicated partners across the watershed. One major event was a tree planting at Church Lane Elementary and Technology School in Baltimore County. BCPS facilities and maintenance teams, Union Bethel AME Church, Interfaith Partners for the Chesapeake, Baltimore County Department of Environmental Protection and Sustainability (DEPS) and Urban Zink. Two years of planning and coordination culminated with a spring planting day with over 100 third grade students and their families. On a day that included a little rain, together we planted 65 native trees on school grounds, positively impacting the community by providing green space and highlighting benefits that trees bring to the school and local community. We will host educational workshops and maintenance events over the next two years and are eager to continue relationships with these students along with our partnership with another BCPS school, Edmondson Heights Elementary, where we planted trees the previous year. Both of these tree planting projects are a key part of our community-based programs and emphasis on connecting with youth.

In addition to amplifying our community engagement, our group programs expanded during FY24 with our new donation-based program that blends environmental stewardship with team building and community/social engagement. This initiative allows organizations to engage in meaningful volunteer activities followed by a social gathering at Manor Hill Tavern. The program empowers businesses and organizations to actively contribute



to preserving the Patapsco watershed while strengthening relationships among team members, the local community, and the environment. The program looks to foster a sense of community through environmental stewardship, provide an introduction to heritage and nature tourism within the PVHA, contribute to enhancing the Patapsco River's health and its tributaries, and support local small businesses. During FY24, we worked with partners at Under Armour, T. Rowe Price, Energetics, University of Maryland Howard County Alumni Association, Serenity Ridge Natural Burial Cemetery, and Conveyor Handling Company, as well as many others listed on the partners page in this report, on a range of stewardship programs. Our community programs coordinator also served as Secretary of the Baltimore County Green Alliance during FY24, helping to expand our partnerships with environmental organizations across Baltimore County.

Another emphasis area in FY24 involved increasing our bilingual and cross-cultural events, which included Es Mi Parque and Hispanic Heritage Month events in Patapsco Valley State Park, a Latino Conservation Week event at Masonville Cove, mentoring a Defensores de la Cuenca La Academia participant on a project for the Baltimore County Public Library, hosting Young African Leadership Institute Fellows for an environmental education, stewardship and recreation event in Patapsco Valley State Park, planning and hosting Festival del Río Patapsco, participating in the STEM Like a Girl event at Soldiers Delight, and hosting the Lakeland STEAM Center for water quality events in Patapsco Valley State Park. We also focused on developing our new watershed video, *A Watershed in Time: Exploring the Patapsco's Past, Present, and Future*, with support from the Kahlert Foundation. The video will explore Maryland's Patapsco Valley to tell the environmental story of how watersheds work, tracing an arc from indigenous people's relationship with the earth to industrial revolution transformations to current restoration activities. We will have a short video premiering this fall and look forward to expanding the project into a longer video that can be used by participants in all of our programs and beyond.

Finally, we hosted our first ever volunteer appreciation event at Ellicott City's Park Ridge Creamery next to our offices, emphasizing the vital role that our volunteers play in helping to steward the environmental, historical and cultural resources of the Patapsco Valley and sharing our a new PHG Steward shirt designed by our marketing coordinator Gaelyn Mitchell. We are continually reminded that the key to our success is our broad network of volunteers who make our programs and work possible.

PASNAPSCO

Patapsco Heritage Greenway's sixth annual PaSNAPsco photo contest invited amateur, professional, and student photographers to capture the region's history, landmarks, and natural beauty. In 2023, forty-one photos from seventeen photographers were submitted. A panel of judges selected winners in each of the six categories, including a Best of Patapsco, while a People's Choice award was decided through social media voting. Winning and honorable mention photos were featured in PHG's 2024 calendar to promote local photographers and showcase the unique character of the Patapsco Valley. Additionally, winning photos from 2020, 2021, and 2022 were displayed in a PaSNAPsco photography exhibit at the Baltimore County Arts Guild's Catonsville Clubhouse.
