Spring 2021 Season

Thank you to everyone for supporting PHG's Spring 2021 stewardship season. Together with over 200 volunteers, we managed to remove almost 9,000 pounds of trash, 13 acres of invasive plants, and plant 80 native trees in the Patapsco watershed. We appreciate everyone hanging with us as we adapted to the circumstances and modified our procedures. We've learned a good deal that will help us streamline future events as we return to a more normal environment this summer and fall.

Howard County PREP Grant

Our \$35,788 PREP grant through the Howard County Office of Community Sustainability will be fully funded for FY22. This is a new grant—funds are generated from the county plastic bag fee—and will allow us to continue our water quality monitoring program and hire someone to lead this effort in the coming year. Thanks to our current CBT CCC intern, Abri Segal, for doing heavy lifting on this application and for launching the water quality monitoring program this year. Abri will be with us through July before heading to graduate school.

Patapsco Regional Greenway Update

PHG is pleased to report that our state delegation secured \$1.25 million in funding for the Elkridge to Guinness Open Gate Brewery trail connection. We appreciate the support from the state delegation and know that this is a vital first step in increasing recreational trail access in this section of the PVHA and ultimately across the entirety of the Patapsco Valley. On the other end of the Valley, Baltimore Metro Council hosted a public meeting on May 27 regarding the planned Sykesville to McKeldin section of the Patapsco Regional Greenway. The meeting highlighted some of the design challenges that exist both within the state park as well as transportation, access and vehicle-pedestrian issues of running the Greenway into Sykesville. Looking for a fun way to get outdoors? Come cool off by the river and check out our water quality monitoring program! Over the past few months, we have been collecting chemical and biological water quality data at eight sites through the Patapsco watershed. We monitor for bacteria, temperature, pH, dissolved oxygen, conductivity, nitrite, phosphate, water clarity. Water quality data helps us assess the health of our streams and identify areas of concern within our watershed. Remember that you can help control the health of our streams! One way you can take action is through picking up your pet waste. Pet

waste increases levels of bacteria in our streams and also increases nitrites and phosphates (which deplete oxygen from aquatic life). Stay tuned in the coming months to see all the data we've collected so far. Best Depiction of the Patapsco River Award

Pride Month in the PVHA

As Pride Month draws to a close, there's a lot to reflect on regarding LGBTQ+ history. The Patapsco River Valley, and the nation, have been the backdrop to legal discrimination against the LGBTQ+ community. However, the region has also seen the growth of advocacy and activism for the equitable treatment of all people, regardless of sexual orientation or gender identity. For example, Benjamin Banneker, who some historians believe was gay, leveraged his education and personal connections to advocate for equality for all to Thomas Jefferson in 1791. In the 1940s/50s, author Robert Lindner advocated for the decriminalization of homosexuality from his Catonsville home. In 1975, Howard County became the first county in Maryland to include sexual orientation as a protected class from discrimination in housing, employment, and public accommodations. Ranging from individual efforts, to broader structural changes, the Patapsco Valley has worked to

also become a place of healing for the LGBTQ+ community.
